    - Working on allocation approach; next County GSAs' Advisory Committee meeting is 10/1 at 2p.m. via Zoom
    - County to follow up on SALC grant and watershed coordinator at next meeting with RCD
- Mark Hutson, Presentation on Arundo
  - Mark presented on the Arundo issues and re-growth concerns. This may be opportunity for RCD to work with the county on grants for funding of removal and maintenance of Arundo. Board advised to reach out Jeannie Habben on prior work with Arundo and RCD's involvement.
- Local Working Group Meeting Follow up (Aug 26) Recap of Meeting/Letter from RCD
  - Meeting went extremely well and had attendance of over 40 people. Letter was created and sent to Carlos based on priorities expressed, as well as 5-6 letters from local groups. Letter was included in handout materials for meeting.

  - Madera/Chowchilla RCD will not join group officially but Laurel will attend meetings and continue to participate.
- **RCPP update:** "San Joaquin Valley Land and Water Conservation Collaborative," which will be funded by a \$10 million Regional Conservation Partnership Program (RCPP)
- Grants recently secured/applied to & Upcoming Grant Opportunities
  - Good News: \$25K from Water Foundation check expected end of September (what account should it go to)
    - Money will be deposited in County account upon receiving
  - **Good News:** Grant Agreement finalized for NRCS capacity grant \$30K
  - o DOC 2020 RCD Financial Assistance Program (June 25) (applied \$25K)
  - Rose Foundation (applied for \$25K)
  - Carbon Hubs Funding Group Laurel is representing region on preparing that.
    - CCI and CARCD providing \$1k stipend.
