- County GSA has held workshops in past month for satellite imagery technology (IrriWatch) and a small farmer education meeting
- Priscilla Baker, NRCS: updates on forest thinning project in North Fork and attendance at CA Dairy Sustainability Summit
  - Forest thinning project in North Fork demonstrated how areas of thinning were less affected by recent wildfire and how successful application can impact the foothills.
     Photos presented by Priscilla came from Kinsman Flat after Creek Fire
  - Dairy Sustainability Summit was held virtually November 5-6. The summit featured more than 50 expert speakers throughout the two days of keynote presentations and panel discussions. Some key presentations mentioned:
    - Dr. Frank Mitloehner Rethinking Methane
    - Geoffrey Vanden Heuvel SGMA Strategies: How Dairies Can Best Manage Fast-Approaching Implications of the Sustainable Groundwater Management Act
    - Managing Manure to Create a Circular Fertilizer Economy
- Getting to work M/CRCD hub: RCD Technical/Education Support and Healthy Soils Workshop (Matt)
  - Workshop will be in help in December pending date, and presenters with a focus on cover crops via a hybrid model (virtual/farm demonstration). Matt to lead development of workshop and provide Stefani with details for flyer/outreach support
  - RCPP launch update: Recharge with AFT, NRCS and RCDs (Laurel)
    - Launch is pending contract with AFT & NRCS to provide technical help
  - Website amplifying the use of website (Matt)
    - Needs/expectations of website need to be evaluated by board to help guide the direction of website use and new website manager
- Arundo discussion: Mark Hutson
  - Arundo removal is costly and funding is lacking for maintenance. Previous grant may help guide next steps for M/C RCD in funding for future Arundo removal/maintenance projects.
    - There was a motion made by Matt Angell to create a subcommittee from M/C RCD on Arundo removal in the county lead by Mark Hutson and Tim Coelho. There was a second from Jay Bellach and the motion passed unanimously by all present directors.
