 - B. Introduction of Guests Guests in attendance were Trina Walley (East Stanislaus RCD), Joy Hollingsworth (UCCE), and Cristina Murillo-Barrick (UCCE)

II. Approval of Minutes

- **A. Approval of Special Meeting Minutes** Motion was made by Tim Coehlo to approve June 2021 Special Meeting Minutes, there was a second from Matt Angell. Motion passed unanimously by all present directors.

- IV. Public Comments Tire Recycling Program through Madera County was discussed by Tim Coehlo. Trina Walley (East Stanislaus RCD) discussed an opportunity for the RCD to be involved with the Stanislaus Grown Magazine. Amy Siliznoff discussed the Working Lands Solar Study from Stanford and how the Directors can get involved.

 - A bunch of Subbasins are meeting together to discuss subsidence and how that's occurring. They want to focus on the Chowchilla Western Area. They're meeting every two weeks. The County GSA adopted allocation, refinements have gone back to the Board.
- B. NRCS Report Priscilla Baker
 - Uniformity testing issues for growers
 - o Brian Hockets for NRCS for EQUIP funding (1 year grant extension)
 - Hose replacements available
 - Chris Yohannan planner has started with Madera/Chowchilla RCD, he has gone out on site visits with Priscilla

- End of ranking for CIC drought more applications for irrigation implementation, soil impact, and wildlife funding
- C. Madera Region IRWM/RWMG Amy Siliznoff
 - Self-Help Enterprises: High frequency calls to enroll Madera County into Water Tank Program
 - They are working on Indian Lakes project to install meters
 - Creek Fire Tour along scenic route
 - San Joaquin Valley Workshop on Drought (Fresno State is also included on this)
 - Utilizing Self-Help Funding
 - Going over water tank program (no income verification)
 - Water well program (income based 80% median income)
 - Bottled water program (income based they will get drinking water to you if your well is contaminated)
 - 27 wells went dry in a week, 57 within the valley (total), they are trying to keep constant outreach going
 - Amy added their information on how to sign up for the program onto our website under resources – drought tab
 - August 11th 5:30PM, public meeting on Nitrates, free well testing

 - Two-Segment Workshop for Orchard Recycling in the Fall (End of October/early November)

 - Amy is working with Coarsegold and Columbia RCD, as well as Priscilla with NRCS to set up the Local Workgroup. The Workgroup will take place on October 7th from 9-11AM. Amy will be reaching out to partners to make presentations for the meeting.

Jay made a motion to approve the Local Workgroup Meeting with NRCS. Matt seconded. All present Board members approved.

- C. Presentation to GSA's about Soil Health/Water Nexus (I) (A) Amy Siliznoff
 - Amy has reached out to Sustainable Conservation, UCCE, as well as NRCS to put together a presentation to the local GSA's about the benefits of cover crops.
 The presentation will be either September or October. Amy will be confirming this at the Regional Water Management Group Meeting (RWMG) on August 23rd.

Jay made a motion to approve the Local Workgroup Meeting with NRCS. Matt seconded. All present Board members approved.

 Irrigation and Nutrient Management Workshop with ESRCD
 - The workshop is set to October 28th from 8:30AM-1PM.
 - The Contract Agreement between East-Stanislaus and Madera/Chowchilla RCD for the RCPP 4-month short-term funding agreement as well as the MOU was read aloud at the meeting

Tim made a motion to approve the Irrigation and Nutrient Management Workshop, along with the Contract Agreement with East-Stanislaus RCD, pending corrections to the MOU. Motion was seconded by Matt. All present Board members approved.
