# II. Review and Approval of Meeting Minutes & Agenda

# III. Updates, Handout, and Public Comments

- The last Madera County Agriculture Roundtable was on Friday, June 15 at the Madera County Farm Bureau office. They discussed Agricultural Conservation Easements.
- A comprehensive conference on SGMA's next phase: Sustainable Groundwater Planning in California: Important practical legal, technical, business and regulatory information for preparing GSPs. This will be in Sacramento on July 26 & 27 by Law Seminars International.
- Yosemite Peace Symposium A Gathering of Peacemakers will be presented at the Tenaya Lodge on October 26-27, 2018. They will have 12 breakouts in three tracks: Peace and the Environment; Peace and Our Youth; Peace and Human Dignity. Jeannie H has been requested to present at one of the Peace and the Environment break-out sessions. She will be presenting on "Living in Harmony with the New California Landscape." Steve Haze will also be speaking at one of the Environment break-out sessions.

# IV. Correspondence & Mail

Correspondence

The board received the monthly statement from the bank and a letter from the Insurance Co asking the board to update their information, and the invoice for the 2018 to 2019 from Golden State Risk Management was received.

Jeannie H wrote a letter on the behalf of the Board to support the Madera Strategic Wildfire Mitigation Project that is being proposed by the Yosemite/Sequoia Resource Conservation and Development Council for the CALFIRE CA Climate Investment 2017-2018 Fire Prevention Grant Program.

### V. Financial Report

• Monthly Treasurer's Report

Jeannie H distributed the June Financial Report. After discussion it was noted that there were no changes from last month. Norm K made the motion to accept the June Financial Report as presented; Sandy F second the motion; all voted and passed unanimously

Invoices to be Paid

The third quarter check was received, short \$24.87, from the DOC. With this check the board paid Jeannie H for the RCD Coordinator quarter July to September 2017 and the 2018-2019 Insurance Invoice. Norm K made the motion to pay the two invoices presented; Sandy F second the motion; all voted and passed unanimously

#### VI. New Business

Review DOC REV Grant

Jeannie H has been working on the tasks for the REV grant. She completed the set-up of the newsletter for the board that will go on the Website when complete. She created four-months of newsletters. She also wrote articles that could be used for the website or other publications as needed: one for SGMA; 2 for Water Use Efficiency; and 2 for Healthy Soils. She shared these with the board for comment.

Jeannie H also sent the website creation out to bid to two companies to get bids to create the new website. She will work with the web designer when chosen and will keep the board apprised of the progress. It was recommended that articles regarding Arundo removal and clear channels for the website.

• Review Tier 1 Annual Requirements This board has met all their Tier one requirements for 2018. This will be removed from the agenda until the next requirements are due.

Registration is open for the <u>RCD Board Leadership Boot Camp</u> taking place in Oakhurst, CA from September 7-8! Directors from all over the state are encouraged to attend. This is a rare opportunity to participate in a program designed to meet the specific needs of RCD leaders. In this training directors will build the confidence that it takes to be successful in the unique work environment of an RCD and meet other RCD directors doing the same kinds of work.

The RCD Communications Academy is an upcoming training opportunity offered by CARCD as part of the Capacity Building Program. The Academy will launch at this year's conference and be followed by six monthly 1.5-2 - hour online webinars. The focus will be on learning specific communications and marketing approaches and on working to develop a communications plan that is specific to your RCD. The Communications Academy is also where we'll debut the new RCD "message platform," which has been in development for about six months and will provide all of us with consistent messaging and tips for highlighting our unique strengths and stories to various audiences. Durable Collaboration – Madera RCD Consolidation
Jeannie H has been working with Allison from Solid Ground Consulting on the
consolidation between Madera RCD and Chowchilla Red Top RCD. Jeannie H
submitted a proposal to Central Valley Community Foundation for funding to pick-up
any of the costs for the collaboration of the two RCDs. They approved supporting the
RCDs consolidating and/or updating the district boundaries as appropriate.

#### **VII. Old Business**

NRCS Report

Just processed the application for the last official deadline, June 18. Already completed about \$4 million in contracts – water conservation, drip systems, hedge rows for pollinators, tractors, etc. – have about \$2 million in contracts still waiting if funds become available.

### Board Recruitment

There were no suggestions at this meeting, but at some point, this board needs to recruit a member that has skills working with the website when it is created. This new board member could update the website monthly with the minutes, agendas, and newsletters, etc.

- Madera Region IRWMP/RWMG Report
  - June 11 Madera, Government Center
  - July 9 Oakhurst, Raley's Community Room
     The Madera RWMG is currently working on the IRWM Plan Update to bring the
     Plan up to the Proposition 1 Standards. The goal is to have the update completed
     by September or October. The County has completed the Storm Water Resource
     Plan, and DWR has now requested that the SWRP become a part of the IRWM
     Plan. This will be added as an addendum to the IRWM Plan.

July 24th there will be a DAC workshop in Madera. There will be three workshops combined as one: Part 1- community capacity assessment, and Part 2- water/wastewater needs assessment; Part 3 – Tribal needs. The San Joaquin Valley Funding Area sent in their DAC Plan to DWR in May, they are waiting for the final approval. They have hired Provost and Pritchard and Self-Help Enterprises will be completing the DAC Needs Assessment.
