III. Review and Approval of Meeting Minutes & Agenda

- January 2017 Agenda
 - Jeannie H suggested two additions: Discussion/Approval of Y/S RC & D Membership and Discussion of Tier Process; both to be listed under "New Business" Norm K made a motion to approve the agenda with above changes; Jack F second the motion; all voted; motion is carried unanimously
- November & December 2016 Minutes
 Norm K made a motion to approve the minutes from the November and the December meetings; Jack F second the motion; all voted; motion is carried unanimously

III. Updates, Handout, and Public Comments

- Eastman is half full today and 619 cfm is coming in. Hensley is being dropped with the anticipation of more flood water coming from the 3 coming storms.
- Norman and Jack attended the Chowchilla Water District meeting They are running water down the sloughs, but not down the old Chowchilla River so the water has not run near the Faust Dairy. (County boundary near Merced) If they release the water to that area it would be a natural recharge and will help that area. They are going to charge 5.00/Aft through February 1 to the farmers.
- Tree mortality assistance program through the Lion's Club International. (TreeMAP) Funds are available through Lions Club Lion's International. Tim C found out about the program through the Sonora Lion's Club.

Discussion of Tier Process

The public comment period for the Accreditation Program closed as of January 9, the paperwork is then sent to the state office of Administrative Law for approval. This will take another 30 days and then the application process will be created for the base funding. Since the funding program is partially tied to the Accreditation program they will issue applications after launching the Accreditation Program. Most likely they will issue the application requests in February with applications due in late March. This will be on the agenda for the February meeting to discuss the application process and funding requests.

VII. Old Business

NRCS Report

Johnny S stated that he would like to create a "Round-Table" group that would include a wide swath of Madera Co. partners including some RCD members, farmers and ranchers, reps from the various ag associations, and others to discuss the issues germane to the area and assist with representation, understanding and outreach.

The first Funding cycle for this (funding) year ended Friday. The Madera Office had 86 applications/contracts for tractors, tree mortality, drip-projects, which totaled a request of over \$2-million. Last year they covered \$700k in contracts for tractors and 60 applications/contracts, \$400k, for tree mortality. There is now a Joint Two Chiefs initiative that covers four counties; this will add funds to split for Tree Mortality.

Board Recruitment

The Round Table concept is very promising in Board Recruitment. Also, we are still waiting for the Madera RCD to get through their lawsuit to move on with a consolidation of the two RCDs.

The Mountain County group met in December in Murphys to discuss and work on the RFP for the Applicant position for writing the application for the DAC funding. The RFP was completed and approved by all groups in the funding area, it is ready to release at the beginning of the year. The San Joaquin Valley Funding Area had one conference call and met in December in Los Banos. Ara A. from San Luis & Delta-Mendota Water Authority stated that their group is willing to be the Applicant for this funding area. Julia B from Madera County requested a support letter from this group for the Storm Water Resource Plan. The support letter confirms the partnership in participating in the disadvantage communities' planning and outreach. Jeannie H wrote to DWR about the possibility of accessing the remaining Planning funds to update the Madera IRWM Plan. No further funds will be available for planning.
