- Sierra Water Workgroup is having their 2017 Summit on July 24 to July 25 in Kings Beach, CA. Sponsored by the State Bar of California, Environmental Law Section. This will be a 1 ½-day workshop focused on state-wide issues and tools around the theme "Legal and Legislative Strategies to Protecting our Headwaters."

  - Jeannie H discussed with the board moving forward with the audit to complete the last item on the Tier 1 list. Jeannie H will pursue making an appointment with Lori R the CPA; it is now after tax season and time to work on the audit.
- CARCD Annual Meeting November 15 -18
   The CARCD's 72<sup>nd</sup> Annual Conference is on November 15 to 18, at the Hilton Arden West in Sacramento. The REV funding will allow at least two members to attend the conference. Norm K and possibly Tim C
- San Joaquin Region/Area IX Spring Meeting May 19 The San Joaquin Valley – Area IX Regional meeting was held May 19, in Exeter. There was discussion of recruitment issues, engagement issues, and capacity building issues. Five of the RCDs in this region received the DOC RCD funding; 1 for Tier one and 4 for Tier 2. At the end of the meeting, there was a tour of Monrovia Nursery. Jeannie H distributed to the board members who were unable to attend the meeting the SJV Brochure and the RCD booklet created to give information regarding all the RCDs in the region. She also distributed the financials for the regional group.

Programs that they are still working on – tri-color blackbirds, tree mortality, tractor replacement, etc. Katherine is new in the office and she works with Xerxes and will be available to work on a pollinator project or come and speak at an event.

    The Mountain County funding area Coordinating Committee met in Sacramento.
    Roles and responsibilities of the Coordinating Committee, the Applicant, and each region within the funding area was discussed. The next meeting of the DAC Coordinating Committee is June 7. Sierra Institute is now the grant applicant for this funding area. The Mountain/foothill area is underrepresented on the RWMG and needs an actual member to be heading up the DAC funding. A RFP when finalized will be both sent out via direct solicit and ebidboard.com. the deadline will be June 1 for proposal submittals for the IRWM Plan Update. The RWMG will be added as a page to the new County Water and Natural Resources website and that the Water and Natural Resource Director will be responsible for updating the website monthly with the minutes, agenda, and any other new materials submitted for the webpage.
