II. Review and Approval of Meeting Minutes & Agenda

III. Updates, Handout, and Public Comments

- Madera Farm Bureau announced that on July 21 at 11:00 Madera Community College TM11 they will be holding the Agriculture Round Table. There will be a lot of representation there.
- Sierra Water Workgroup is having their 2017 Summit on July 24 to July 25 in Kings Beach, CA. Sponsored by the State Bar of California, Environmental Law Section. This will be a 1 ½-day workshop focused on state-wide issues and tools around the theme "Legal and Legislative Strategies to Protecting our Headwaters." They will be discussing Climate change, DAC Involvement, IRWM plans, and Coordination Advocacy.
- Land Subsidence in the San Joaquin Valley Free briefing to be held at the University Business Center, CSU Fresno on Wednesday, August 16, 2017, 8:30 to 3:30. NRCS Report

The SJ Valley funding area is working on the RFP for finding a company to write the application to DAC; their goal is to submit the application by October 2017. The SJV area is also working on a charter for the members of their group. The RWMG still must update the IRWM Plan to Prop 1 Standards; they did not choose a firm to complete the update. They are going to use the same RFQ and change the due date for the response and send it back out. The RFQ will be reposted July 11 and the new due date will be August 25 to respond. The RWMG will vote at the September 11 RWMG meeting on the proposals.
